Because of your support, the Amari family's story has a happy ending.

After escaping from Aleppo, Syria, the Amari family were approved for resettlement in the US—but then denied entry because of President Trump's Muslim ban. After pressure from Amnesty International, the Amari family are now finally making a new home in Virginia. "I want to thank Amnesty International because the work it does is wonderful," Ahmed Amari said. "Keep doing your work, don't stop!"

You're ensuring Rohingya children can go to school.

Amnesty supporters campaigned with the Rohingya people when nearly half a million of their children were denied an education in Bangladesh's refugee camps. In January 2020, the Bangladeshi government announced it would offer schooling to the children—a major human rights victory.







You're speaking out against the government's demolition of homes in Ghana. The destruction was in the Old Fadama suburb of Accra during a COVID-19 lockdown in April 2020. Robert Akoto Amoafo, Director of Amnesty Ghana, condemned the government's actions, which made hundreds homeless: "The demolition at Old Fadama during a pandemic is wrong."

You're standing with climate justice activist
Marinel Sumook. Marinel's case was featured in
Amnesty's Write for Rights letter-writing event.
"Thank you so much for embracing me and my story,"
Marinel said. "For opening your hearts to us, people
in the Philippines. From the bottom of my heart,
thank you for fighting with us."

You're defending freedom of expression. In July 2020, a court in Jordan found 17-year-old Yemeni refugee Tujan al-Bukhaiti not guilty of "blasphemy". Tujan had been charged in relation to her social media posts discussing religious and cultural issues. She expressed her gratitude to Amnesty members for their support: "I thank Amnesty International for its continuous efforts in the many stages of this case!"

You're campaigning for an end to human rights violations in the production of rechargeable batteries. Amnesty's researchers exposed child labour, environmental harm, and violations of the rights of Indigenous peoples in countries where minerals are mined for use in the production of rechargeable batteries found in laptops, cell phones, and electric cars.

Thanks to your support, Magai Matiop Ngong's death sentence was revoked in July 2020.

Magai was only 15 when he was sentenced to death in South Sudan. "Thank you so much!" said Magai in a message to Amnesty supporters. "I have no words. You have no idea how my heart is filled with happiness."

You helped win a 15-year struggle to overturn the Canada-US Safe Third Country Agreement.

In July, a Federal Court judge ruled that the Safe Third Country Agreement between Canada and the US is unconstitutional. This means sending refugees back to the US is unlawful. Refugees returned to the US are often detained in deplorable conditions, a violation of their human rights.

TAKING ACTION to Hold Police Accountable for Anti-Black Racism







You're supporting a network of activists across Canada. Since the COVID-19 pandemic began, Amnesty activists have been online rallying, protesting, and demanding change. One of the many online initiatives in 2020 was a letter-writing event to hold police accountable for anti-Black racism.

You're supporting those who speak out for human rights. In July 2020, journalist Samira Sabou was freed from prison in Niger after a judge dismissed all charges against her. Samira was detained when she posted about corruption on Facebook. Amnesty supporters were among those that Samira thanked: "I have been touched by the solidarity and the support that I have received!"

You're helping free prisoners of conscience.

In April 2020, Chinese human rights lawyer Wang Quanzhang was released and reunited with his family. He was detained in 2015 during a mass crackdown by the Chinese government. His wife thanked Amnesty supporters: "Your work and help played a big part in bringing him home. We are very thankful for having all of you by our side in this journey!"
